Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Avoid discharge to the aquatic environment. Do not handle until all safety precautions have been read and understood. Do not handle broken packages without protective equipment. Do not spray on an open flame or other ignition source. Do not pierce or burn, even after use. Spray will evaporate and cool rapidly and may cause frostbite or cold burns if in contact with skin. Avoid contact with eyes. Avoid inhalation of vapours and spray/mists.

Appropriate engineering controls

Provide adequate ventilation. Personal, workplace environment or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment. Use process enclosures, local exhaust ventilation or other engineering controls as the primary means to minimize worker exposure.
