SECTION 4) FIRST-AID MEASURES

Inhalation

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Specific Hazards in Case of Fire

Emergency Procedure

Methods and Materials for Containment and Cleaning up

General


