6. Accidental release measures

Keep unauthorized personnel away. See Section 8 of the SDS for Personal Protective Equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them.

Methods and material for containment and cleaning

up:

Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. In case of leakage, eliminate all ignition sources. Dike far ahead of larger spill for later recovery and disposal. Use non-sparking

Avoid release to the environment. Prevent further leakage or spillage if safe to do so.

Precautions for safe handling:

Observe good industrial hygiene practices. Wear appropriate personal protective equipment. Do not expose to intense heat as product may expand and pressurize container.
