## SECTION 4 FIRST AID MEASURES

**Skin:** High-Pressure Equipment Information: Accidental high-velocity injection under the skin of materials of this type may result in serious injury. #### Indication of any immediate medical attention and special treatment needed

#### SECTION 6 ACCIDENTAL RELEASE MEASURES
